Goods that are AANZ originating goods imported from the above countries, for which a date and Gazette details appear in the above table, qualify for preferential rates of duty on and from the indicated date of entry into force of the ASEAN-Australia-New Zealand Free Trade Agreement (AANZFTA) for that country, if they meet the provisions of Division 1G of Part VIII of the *Customs Act 1901*.

Further information on eligibility for preferential rates of duty is available from Australian Customs Notice 2009/44. Australian Customs Notice 2009/51 provides information on entry into force of the AANZFTA.

Where applicable, rates of duty for AANZ originating goods are set out in Schedule 8 of the *Customs Tariff Act 1995* (the Tariff Act). Where no rate of duty is specified for a particular tariff classification, the rate for AANZ originating goods is Free.

This table is not part of the Tariff Act but has been included in the Customs Tariff Working Pages for the information of importers. The Australian Customs and Border Protection Service will update the table as required.

The entry into force date for the remaining ASEAN Member State of Indonesia is subject to implementation of domestic legislative requirements by that country.

Imported goods from Indonesia are not originating goods until the AANZFTA enters into force for that country. It is therefore not possible to apply the AANZFTA to goods imported from Indonesia until this occurs.

Revision 1 (R.1) of this page reflects the entry into force of the AANZFTA for Malaysia, from 1 January 2010. Australian Customs Notice 2009/53 refers.

Revision 2 (R.2) of this page reflects the entry into force of the AANZFTA for the Philippines, from 1 January 2010. Australian Customs Notice 2010/02 refers.
